» 5.3 Community Heritage Commission - Re: Conservation of the Eagle Ford Neon Sign

City Council voted to restore and reinstall the vintage Eagle Ford neon sign on Hastings Street. The sign, which is over 13 feet tall and nearly 9 feet wide, is a well-known landmark which was originally located at the showroom of the Eagle Ford car dealership at Carleton Avenue and Hastings Street in the 1950s. Once the sign is reinstalled on Hastings, it will be designated as a civic heritage feature within Burnaby.

» 5.6 Environment Committee - Re: Drinking Water Quality 2021 Annual Report

City Council reviewed the Drinking Water Quality 2021 annual report, which indicated that Burnaby residents continue to enjoy high quality drinking water. The report outlines the annual maintenance and monitoring done by Metro Vancouver and the City to maintain Burnaby's excellent water quality year over year.

» 5.8 Parks, Recreation and Culture Commission - Re: 2022 Park Dedication

City Council voted to move forward with a ballot referendum, which will ask Burnaby residents to share their opinion on dedicating four areas in Burnaby as parkland. The City lands proposed for dedication are located at the west end of Burnaby Lake, in the Cariboo and Brunette River area, at the west end of Deer Lake Park, and along the Stoney Creek park and trail system, comprising 204.05 acres in total. Burnaby residents will vote on this ballot referendum during the 2022 local government election.

» 5.12 Planning and Development Committee - Re: Official Community Plan (OCP) - Project Initiation, Process and Upcoming Next Steps

City Council received a report outlining the work done so far to prepare for a full review and update of Burnaby's Official Community Plan (OCP). The Burnaby OCP project is a multi-year, multi-phased project with the goal of building a new Official Community Plan to guide and manage the growth of Burnaby over the next 25 years. The City will host a series of pop-up public engagement events throughout the summer to help inform Burnaby residents as this process continues to move forward.

» 6.1 Extreme Heat Operational Response Plan

City Council was provided information about the City's Extreme Heat Operational Response Plan. The plan outlines how City staff will work with community partners and local health authorities to protect vulnerable Burnaby residents in the event of extremely heat. Additionally, the City will open four cooling centres at the Eileen Dailly Leisure Pool and Fitness Centre, Cameron Recreation Complex, Bonsor Recreation Complex and the Edmonds Community Centre in the event of an extreme heat event in Burnaby.

» 6.11 Rezoning Reference #21-44 - Renovations to Existing Mall - Brentwood Town Centre Development Plan

City Council voted in favour of a rezoning application to allow for major renovations and seismic upgrades to the existing Brentwood Town Centre Mall. In addition to making seismic upgrades to the mall, the applicant proposes replacing the pitched fabric roof with a more energy efficient design, creating new entries to the mall, demolishing the commercial area formerly occupied by Sears, and making various upgrades to the interior.
