

CITY OF BURNABY COUNCIL IN BRIEF

January 31, 2022

» **[Traffic Safety Improvements at Parker Street and MacDonald Avenue](#)**

Council authorized City staff to install a series of traffic calming measures at this intersection, including new pedestrian crossing signs, new speed display boards, and curb extensions. These measures will be installed as soon as possible.

» **[Burnaby Mountain Gondola Endorsement](#)**

Council endorsed the Route 1 option for TransLink's Burnaby Mountain Gondola Project, the direct route from Production Way-University SkyTrain station to the SFU campus. In order for the project to proceed, it will need to be adopted by the Mayors' Council on Regional Transportation and included in the new 10-Year Vision being developed by the Mayors' Council.

» **[Burrard Inlet Rapid Transit Endorsement](#)**

Council endorsed the Burrard Inlet Rapid Transit (BIRT) initiative, which would create a rapid transit link to the North Shore. Council specifically endorsed the "Purple Alignment," which would create a north-south link from Burnaby to the North Shore. In order for the project to proceed, it will need to be adopted by the Mayors' Council on Regional Transportation and included in the new 10-Year Vision being developed by the Mayors' Council.

» **[Burnaby Hospital Redevelopment – Development Variance Permit Application](#)**

Council approved issuance of a Development Variance Permit to facilitate the construction of the Burnaby Hospital Redevelopment Project, Phase 1.

» **[Rezoning Applications \(4567 Lougheed Hwy, 3700 Willingdon Ave, 3990 Marine Way, 4472 Hastings St\)](#)**

Council authorized the Planning and Development Department to continue to work with applicants toward the preparation of suitable plans of development for presentation to future public hearings.

» **[Broadway Street Improvements](#)**

Council approved a contract increase of \$4,158,774.33 to cover the cost of unexpected issues that were identified through the course of construction on Broadway Street. During construction, it was discovered that some third party utilities were not installed as per their as-built record drawings, and a new storm sewer also needs to be installed on the north side of Broadway.

» **[Non-Market Housing at 8305 11th Avenue](#)**

Council approved first reading of an amendment to Burnaby Zoning Bylaw 1965 in order to establish development guidelines for the subject site to facilitate development of non-market housing.

» **[2022-2026 Financial Plan](#)**

Council adopted the 2022-2026 Financial Plan.
