» Child Care Resources Group Update for 2022

City Council received a report from the Social Planning Committee, which outlined the Child Care Resource Group's key activities and accomplishments during 2021, and a proposed work plan for 2022. Council also approved an \$800 expenditure to support the Child Care Provider Appreciation event on May 26.

» Proposed Framework for the Keeping of Backyard Chickens

City Council approved a framework for allowing Burnaby residents to keep backyard chickens. Staff will now prepare bylaw amendments and present them to council for a vote at a future meeting.

» Parking Concerns on Curle Avenue, Kalyk Avenue and Nithsdale Street

City Council voted to maintain resident parking only signage on 3 streets near the Burnaby General Hospital, in response to parking concerns raised by area residents.

» Citizen Support Services 2021 Annual Report

City Council received the 2021 Annual Report from Citizen Support Services (CSS), which outlines the key accomplishments and projects completed by CSS. This report also outlines the extensive support provided by CSS to Burnaby seniors during the COVID-19 pandemic.

» Annual Youth Week Block Party

City Council approved a road closure on Jubilee Avenue from Nelson Avenue to Imperial Street on Saturday, May 7 between 10 am and 6 pm, to accommodate the Youth Week block party.

» Contract Award - Burnaby Lake Rowing Pavilion Grandstand Rehabilitation

City Council awarded a contract for \$1,313,244.11 for the structural rehabilitation of the Burnaby Lake Rowing Pavilion Grandstand area.

» Contract Award - 11th Avenue Combined Sewer Separation

City Council awarded a contract for \$4,498,441.50 to Sandpiper Contracting LLP for a watermain replacement and combined sewer separation project on 11th Avenue.

» 2022 Local Service Tax Bylaw

City Council authorized staff to bring forward a Local Service Tax Bylaw, which will impose parcel taxes on properties in three specific areas in Burnaby, in order to pay for recently completed improvements in these locations.

» Tourism Burnaby - Change In Constitution And Bylaws - Board Of Directors

City Council were informed about recent changes to the constitution and bylaws for Tourism Burnaby, to increase the number of board members from 7 to 11.

» Grosvenor Brentwood Conceptual Master Plan - Brentwood Town Centre Development Plan

City Council authorized staff to bring the Conceptual Master Plan for this site to public hearing on April 26.

[» RELEASED FROM CLOSED MEETING: Kingsway and Edmonds Conceptual Master Plan - Comprehensive Redevelopment and Partnership with BC Housing](#)

City Council approved the release of a report from a closed council meeting, regarding preliminary plans for a joint venture between the City and BC Housing to redevelop properties at 7252, 7264, and 7282 Kingsway. The preliminary design includes 5 high rise towers and up to 2,815 units of housing, including a mix of market and non-market units.
