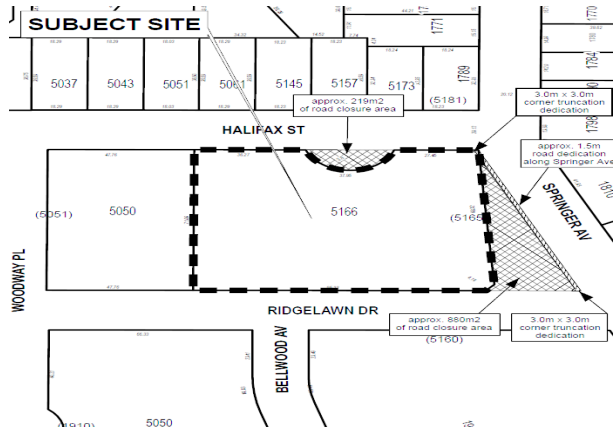


# Public Notice: Highway Closure Bylaws

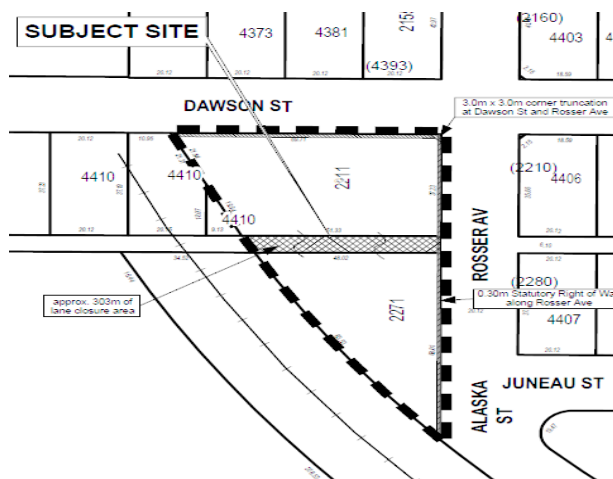
Notice is hereby given pursuant to section 40 of the *Community Charter*, that the following proposed Highway Closure Bylaws be presented before City Council for final adoption at the regular Council Meeting scheduled on **January 28, 2025**.



**BYLAW NUMBER:** 14714

**BYLAW NAME:** Burnaby Highway Closure Bylaw No. 7, 2024  
(ROD #24-04, REZ #22-09)

**Purpose:** to close certain portions of highway – closure of portions of road on Halifax Street, Springer Avenue and Ridgelawn Drive (portions of road dedicated by Plan 33521 in District Lot 125, Group 1, New Westminster District containing 218.70 m<sup>2</sup> and 1000.90 m<sup>2</sup>) shown as Parcel “A” and Parcel “B” and outlined in bold on Reference Plan EPP142325 prepared by Sebastiano Loconte, B.C.L.S.



**BYLAW NUMBER:** 14715

**BYLAW NAME:** Burnaby Highway Closure Bylaw No. 8, 2024  
(ROD #24-02, REZ #22-08)

**Purpose:** to close certain portions of highway – closure of lane 2211 and 2271 Rosser Avenue (portion of lane dedicated by Plan 2855 in District Lot 119, Group 1, New Westminster District containing 302.8m<sup>2</sup>) as shown outlined in bold on Reference Plan EPP142613 prepared by Haeme Lee, B.C.L.S.
